



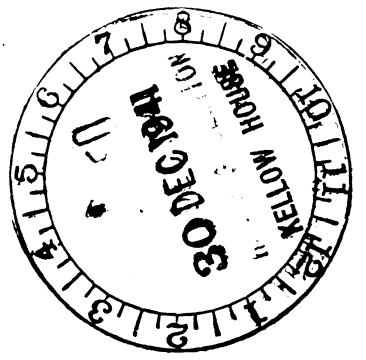

With reference to your recent application for admission to the Royal Australian Air Force, it is requested that you report to the above address on January 27th. 1940 for enlistment as a Aircraft Hand in Group 5 with the rank and pay of Aircraftsman, Class 1. Report at 9 a.m. Be prepared to go to Laverton, Victoria for enlistment. Please bring with you the following certificates applicable to you:-

- (i) Birth Certificate or Extract of Birth Entry.
 - (ii) Marriage Certificate.
 - (iii) Birth Certificates of any children.
 - (iv) Naturalisation papers.
 - (v) Militia, Army or Naval discharge.
 - (vi) Parents' or guardians' consent if under the age of 21.
3. Enlistment is for the duration of the war and up to a period of twelve months thereafter.
4. The daily pay applicable to your appointment is Five shillings per day. Married men are paid a separation allowance of 3 shillings per day, and 1 shilling per day for each child under the age of 16 years. The payment of separation allowance is subject to the airman making an allotment of at least 3 shillings per day.
5. All airmen are provided with free messing and accommodation. Uniforms and necessaries are also provided at Departmental expense. The full scale of uniform however is not issued immediately on enlistment.

The following information has been conveyed to the applicant, whose signature is appended :—

1. On enlistment, airmen become subject to the Air Force Act and Air Force Regulations as amended from time to time and Orders promulgated under the authority of that Act and Regulations.

2. Enlistment will be for the duration of the war and for a period of not more than twelve months thereafter.

3. Enlistment is for service anywhere, and no guarantee can be given as to location at any time, but the wishes of personnel will be considered as far as the exigencies of the Service permit. Airmen must be prepared to serve overseas or in Australia.

4. Promotion to higher ranks, re-muster to other trades, and transfer to other units are governed by the following factors :—

- (a) the requirements of the Service ;
- (b) the existence of vacancies ;
- (c) the special qualifications of an airman for holding any position other than that to which he has been appointed

5. Promotion, re-muster, or transfer is always by selection and cannot be claimed as a right by any airman.

6. Re-muster to another trade is subject to the applicant having passed the prescribed trade test, and subject to vacancies occurring in approved establishments.

7. The passing of an examination for promotion, or a trade test for re-muster, does not entitle the airman to immediate promotion or re-muster, as promotion is always governed by the conditions set out in paragraphs 4, 5, and 6 above.

8. An airman may be discharged at any time for any of the reasons laid down in Air Force Regulations.

9. An airman's fare is paid from his place of residence to his place of enlistment. A married man, who desires to bring his wife and children to his place of enlistment may do so at his own expense.


